SALE OF TENDER / BID DOCUMENT

The bidders have to download the Tender Documents directly from website available at <https://bbmchbalangir.nic.in> , <http://dmetodisha.gov.in> .The tender cost fee of Rs.1000/- (one thousand) Demand Draft drawn in favour of Superintendent, BBMC&H, Balangir payable at Balangir should be enclosed along with the Bid document seal Cover-A, i.e. technical bid & sealed price bid should be enclosed in another envelope Cover-B, i.e. price bid. Then both the envelopes should be enclosed in the third envelope. The Bidders should specifically superscribe, Downloaded from the website” on the top left corner of the outer envelope Bid. The Tender paper cost fee and the EMD amount Rs.10,000/- (Rupees Ten thousand only) should be submitted in separate demand draft. In case of any bid amendments and clarification, responsibility lies with the bidders to collect the same from the website before last date of tender document and the Superintendent shall have no responsibility for any delay / omission on part of the bidder.

The tender will be rejected if the bidder changes any clause or Annexure of the bid document downloaded from the website.

A. Tender paper Fee and EMD:

THE tenderer should furnish the EMD of Rs. 10,000/- (Refundable) and Rs.1,000/- towards tender paper fee (non-refundable) in shape of Bank Draft in favour of Superintendent BBMC&H, Balangir payable at Bank of India, Balangir. The EMD of approved supplier will be deposited (as performance security) and will be returned after completion of the tender period without interest. However the EMD of the non- responsive bidder will be returned after completion/finalization of the tender process.

B. ELIGIBILITY CRITERIA

The firms having registered and experience for manufacturing, supply and having service point in the same district of the electric vehicle are eligible to participate in tender provided they have to submit the following documents:

- (i) Tender processing fees of Rs. 1000/- and EMD amounting to Rs. 10,000/-
- (ii) Copy of GST registration.
- (iii) Piece bid (as per Annexure-I).
- (iv) Details of address, contact no. of responsible person, email, fax etc.
- (v) Affidavit of declaration as per Annexure-II.

C. PRICE BID

The tender format giving the quoted rate should be sent in separate cover hereafter called Cover “B” (Price Bid). The tender format (Price Schedule) in duplicate in prescribed form (as per Annexure). The price of the item should be quoted inclusive all the taxes and levies if any. The rate should be quoted for each item both in figures and words. Only two decimal points (paise) will be taken into consideration ignoring the rest digits. In case of difference in words and figures, words will be taken into consideration for evaluation. GST to be quoted separately as per schedule. The quoted rates should be final and shall not be subject to any escalation during the validity of the tender.

D. REJECTION OF THE TENDER:

The tender paper will be rejected if any of the following documents are wanting / not found with the tender bid:

- (i) Non submission of relevant documents
- (ii) Price bid/ quoted rate with signature and seal of authorized person of the firm.

E. EVALUATION:

1. The tender paper will be evaluated as per requirement of the bid and the price bid will be opened only for the bidders who qualified in the document evaluation (technical bid)
2. The cost of the unit item excluding GST will be evaluated.
3. If the approved lowest eligible supplier fails to supply items in time, to meet the requirement the same shall be procured from the L2/L3 suppliers at L1 rate, if they agree to supply at L1 approved rate.
4. However, the authority reserves the right to negotiate with the L2 bidder to match the L1 price for steady and continuous flow of oxygen and other gases for the interest of the patients in case of exigency.

F. PAYMENT:

1. 100% payment shall be made after submission of stock entry/ handing over certificate from the concerned authority.

G. GENERAL CONDITIONS:

1. The Tender documents should be clearly written / typed without any correction, interpolation and overwriting. Each page of the tender should bear the dated signature of the tenderer.
2. All the pages of the tender document should be numbered and self-attested. Of any information or documents furnished by the tenderer found to be misleading / incorrect at any stage, their tender will be rejected.
3. The approved rate and supplier will be valid for one year from the date of approval and may be extended on review on mutual agreement with the same terms and conditions subject to satisfactory performance of the approved supplier.
4. In the event of the last date of submission of bid date being declared as a holiday for the purchaser's office, the due date submission of bids and opening of bids will be the following working date & time.
5. The authority reserves the right to accept / reject all the bids or any part thereof without assigning any reason thereof.
6. All legal disputes, if any relating to purchase etc. are subject to jurisdictions in the court of law situated at Balangir.
7. The supply should not be interrupted due to any event or power failure. The firm should have responsibility to supply the items on his own arrangement in time.
8. The authority reserve the right to procure items from L2/L3 firm in case if firms fails to supply in time and to manage any exigency that arises.

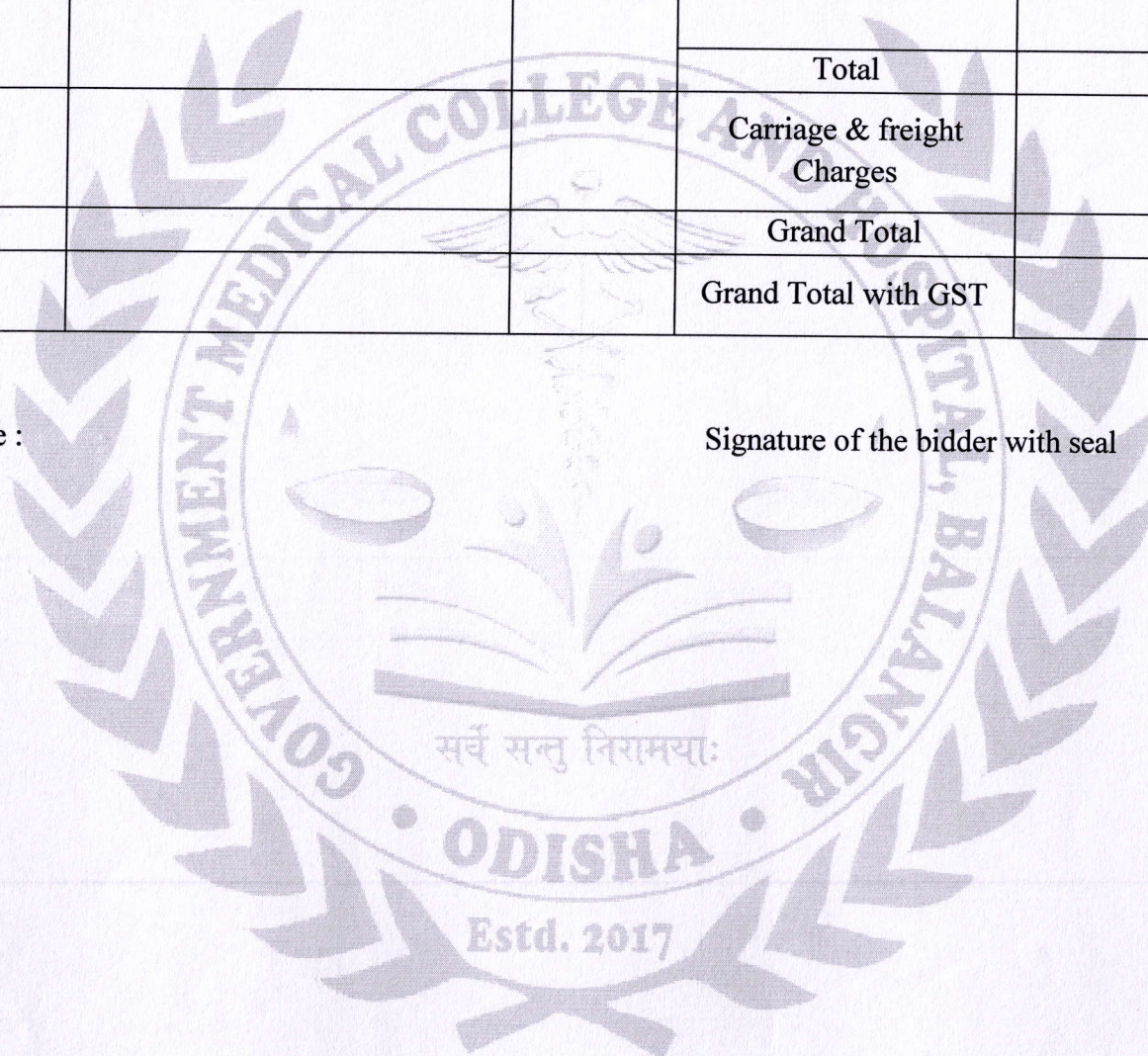

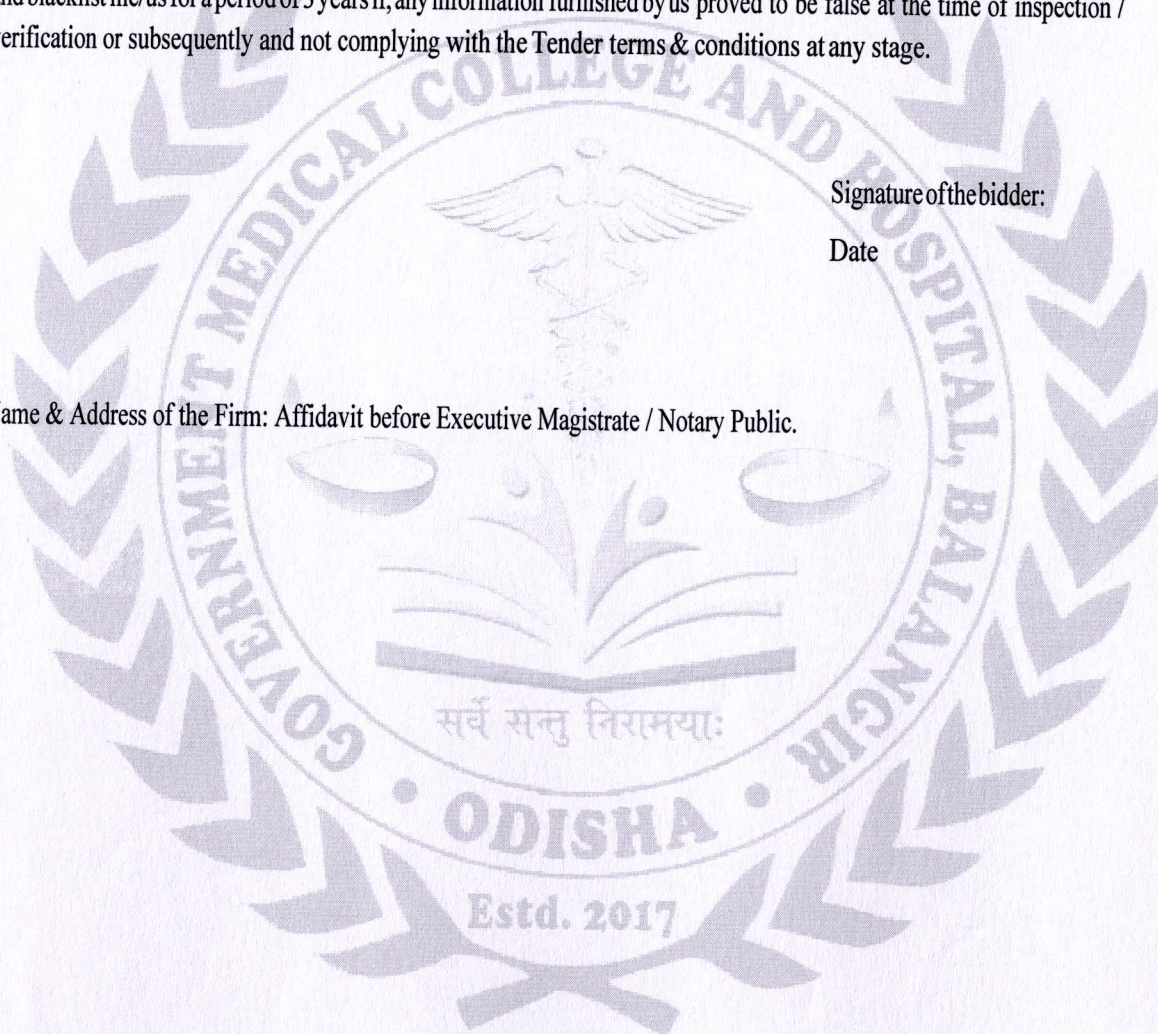
