1. The bidders have to submit their tenders in separate sealed covers (i.e. **Cover "A" – Technical Bid & Cover "B"- Price Bid**). Both the covers should be put into a third Cover "C" which must be super-scribed as "Tender for "Supply of Mahaprayan / Deadbody carrier vehicle".
2. **The Cover "A" (Technical Bid) should contain as follows "-**
 - a) Checklist with details of the documents enclosed in Cover "A" (as per Annexure-I) with page number. The documents should be serially arranged as per this Annexure-I and should be securely tied and bound.
 - b) Manufacturing unit / supplier, who has been blacklisted either by the Tender inviting authority or by any state Govt. or Central Govt. organization, is not eligible to participate in the tender for that item during the period of blacklisting. They should submit a declaration about this by a Notary Public (Annexure-IV).
 - c) EMD Rs. 5,000/- (Rupées five Thousand only – refundable) in shape of Bank Draft / Bankers Cheque in favour of Superintendent, Balangir payable at BBMC&H, Balangir.
 - d) Tender Paper Cost Rs. 1,000/- (Rupees One Thousand Only – Non-refundable) in shape of Bank Draft / Bankers Cheque in favour of Superintendent, Balangir payable at BBMC&H, Balangir.
 - e) The specification of the Mahaprayan vehicle / Deadbody carrier should be as follows :

- l) Leaflet / Technical Brochures of the products / item to be offered.
- m) They should quote the rates inclusive of excise duty, insurance, packing, forwarding, freight (door delivery) and excluding GST (if any) and should submit a self-declaration about this.
- n) They must submit the undertaking that they will supply the stocks within Fifteen days after receipt of the Purchase Order from this office.
- o) The supplier shall have a minimum annual average turnover of Rs. 50 Lakh or more in the last three year financial years. (2020-21, 2021-22, 2022-23)
3. General Condition :
- a) Eligible bidders should submit their tender documents to the Superintendent, Bhima Bhoi Medical College & Hospital, Balangir through Speed Post / Registered Post with in the stipulated date & time as mentioned in the tender notice.
- b) Any tender documents received after the due date & time will be summarily rejected and will be returned to the sender unopened.
- c) Violating the tender terms and conditions & non-supply / partially supply / supply, which is not as per technical specification, will be declared as Blacklisted and disqualify the firm to participate in any tender of this district for a period of next 03 (Three) years from the date of issue of the letter and their E.M.D. will be forfeited.
- d) Tenders documents should be typewritten or computerized, failing which the bidders will be ineligible for consideration. No further correction will be allowed.
