

Terms and conditions for In-service Candidates:



- (ii) The Regular In- service candidates shall be allowed to draw salary from the post against which they are posted in MCH.
- (iii) For In-service Assistant Professor, Salary, Pay Protection and other service conditions shall be governed as per provisions of Health & Family Welfare Department Letter No. 6547/H Dt. 04.03.2017
- (iv) The terms and conditions relating to Job responsibility and etc. of Asst. Professor on deputation basis will be guided as per the Clause-9 of Health & FW Resolution No. 8967/H Dt. 25.04.2022
