The Dean & Principal shall have no responsibility for any delay on the part of the bidder. The Technical Bid and Financial Bid/ Price Bid will be opened on the scheduled date & time in the College Council Hall, O/o Dean & Principal, BBMCH, Balangir. In case of absence of any bidder, then also the bid documents will be opened by the committee members on the scheduled date & time.  - b) Bidders having more Avg. Annual Turnover.
 - c) Bidders having more experience, if provided in the Bid document.
- After Financial Evaluation, the L1, L2 & L3 Bidders will be called for Demonstration of the Devices & Quality Checking of the devices will be conducted by the Institutional Purchase Committee. The Purchase Order/ Work Order Shall be issued to the Bidder having more satisfactory demonstration and Quality of devices.
