


SHORT TENDER CALL NOTICE FOR SUPPLY OF ORTHOPAEDIC IMPLANTS / ITEMS TO DHH / BBMC&H, BALANGIR FOR THE YEAR 2025-26

Sealed Tenders are invited (Wholesalers/Distributor/Manufacturer) for supply of Orthopedic Implants (set as per demand) on annual rate contract basis. The Tenderers have to download the **Documents** directly from WEBSITE available www.bbmchbalangir.nic.in.&www.balangir.odisha.gov.in.The Tender processing fee of Rs 2,000/- (Non-refundable) & EMD of Rs 10,000/- in the shape of Demand Draft only in favor of Superintendent, BBMC&H, Balangir, from any Nationalized / Scheduled Bank payable at Balangir should be enclosed along-with the tender paper/proposal. The Tender papers will be received through Courier /Regd. Post / Speed Post only and should reach in the office of the undersigned on or before 13.05.2025 up to 5.00 PM. The tender will be opened on the scheduled date & time in the Conference-cum-meeting Hall, O/o Superintendent, BBMC&H, Balangir in presence of the Committee members and the Tenderers or their authorized representatives. In case of absence of any bidder then also tender document will be opened by the committee members.

Terms & Conditions

- 1. The Tender papers should be properly sealed and super-scribed as "Tender for supply of Orthopedic Implants to DHH/BBMC&H, Balangir for 2025-26".
- 2. The Tender will be in two parts i.e. Technical bid (Cover-A) and price bid (Cover-B). The bidders should submit their technical and financial proposal separately in two envelopes and should be put into another cover superscribed as "Tender for supply of "Orthopedic Implants / Items".
 - All the documents for the Technical Bid & Financial Bid must be submitted in hard copy.
- 3. The technical bid and price bid should be sealed in separate envelope otherwise bid will be rejected. The bid will be rejected for any shortfall of required documents as per terms and conditions. No further add-on of documents will be allowed in the future. The tenders should be addressed to:

- 4. The authority is not responsible for any type of postal delay. The tender document will not be received/entertained after due date & time fixed for receipt in the advertisement and will be summarily rejected.
- 5. The Tenderer shall have to furnish the following documents along with the Tender proposal
 - i. Rs 2,000/- (Non-refundable) the Tender document cost is to be submitted in the shape of the Demand Draft in favor of SUPERINTENDENT, BBMC&H, Balangir payable at Balangir.
 - ii. EMD of Rs. 10,000/- (Refundable) in the shape of a Demand Draft in favour of SUPERINTENDENT, BBMC&H, Balangir payable at Balangir.

- Photo copy of the Valid Drug License of the Bidder (Wholesalers / Distributors / Manufacturer as the case may be) from the Licensing Authority i.e. drug Controller or deputy drug controller shall be submitted. If the original drug license has been expired, then the bidders have to submit the renewal license retention certificate and challan copy along with the old drug license. Non submission above relevant drug license documents will be treated as technically disqualified in the tender process.
- iv. Copy of valid manufacturing authorization certificate in original for this tender only from the manufacturer and it shall be clearly mentioned on the letter head of the manufacturer. Manufacturing authorization certificate along with the CE Certificate for the same manufacturer must be produced. Failing which the bidder will be technically disqualified.
- v. Photo copy of the I.T Return for 2021-22, 2022-23 & 2023-2024.
- vi. Photo copy of valid CE Certificate / US FDA Certificate.
- vii. Photo copy of valid PAN card.
- viii. Photo copy of valid GST Registration Certificate.
- ix. Photocopy of GST return for the last quarter (Jan 24, Feb 24 & Mar 24) shall be submitted.
- x. Proof of supply of orthopedic implants for the last 02 years. (End user/ performance certificate) must be submitted.
- xi. Proof of Average Annual Turnover of bidder (Wholesalers / Manufacturers / Distributor as the case may be) of Rs 20.00 lakhs or more during the last three financial years (2021-22, 2022-23 & 2023-24) taken together from a registered chartered accountant shall be submitted Annexure-III. The registration number and Name of Charted Accountant shall be clearly mentioned in the certificate.
- xii. The Bidder will have to submit declaration in the form of an Affidavit on Original Stamp Paper of relevant value as mentioned in the *Annexure II*.
- 6. For financial bid i.e. cover –B information in **Annexure** –**IV** completely filled & must be submitted.
- 7. In case of non-submission of the EMD amount, technical proposal of the bidder shall be rejected.
- 8. The EMD shall be returned to unsuccessful bidders within a period of eight weeks from the date of announcement of the successful bidders without accrual of any interest.

- The EMD shall be forfeited if the bidder withdraws its proposal during the interval between the proposal due date and expiration of the proposal validity period or on in case of successful bidder, if does not execute the agreement.
 The EMD of successful bidder shall be kept as performance security deposit which shall be forfeited if any term or condition of the contract is infringed or if the supplier fails to provide the Orthogodic implents gets satisfactorily. No interest are security deposit and
- provide the Orthopedic implants sets satisfactorily. No interest on security deposit and EMD shall be paid by the tendering authority.

 11. The Wholesalers /Distributor/Manufacturer shall have stocks of all types of Orthopedic implants sets & Items (as mentioned in Annexure IV) as per demand of Orthopedic
- implants sets & Items (as mentioned in Annexure IV) as per demand of Orthopedic Department of the DHH/BBMC&H, Balangir.
 The Orthopedic implants sets of good quality item are to be certified by the technical
- committee. Substandard quality implants as certified by the technical committee after receipt of the item will be returned & replaced with good quality product.

 13. The approved suppliers shall have to supply the Orthopedic implants & Items as per
- requirement and in no circumstances the suppliers shall disobey the supply order otherwise the concerned supplier will be blacklisted.

 14. The approved Implants supplier shall have to execute/ supply order in full. In any case the prescribed item(s) are not available with them and then it is the responsibility of the
- approved supplier(s) to make it available.
 15. The approved supplier shall supply implants as per the order quantity and one technical person must be there from the supplier sides to identify the correct implants at the time
- person must be there from the supplier sides to identify the correct implants at the time of receiving of the materials at the institution level.

 16. The approved Implants supplier(s) shall have to sign MOU with the undersigned before

execution of the contract valid for one year from the date of signing of MOU. It may further be extended for another one year by the Authority subject to satisfactory performance.

- 17. The purchase shall be made on credit basis and the payment will be released as early as possible basing on availability of funds. At any situation, supply shall not be discontinued / delayed due to late payment.18. If any dispute / irregular supply order by the approved supplier(s) is found during the
- contract period, no further purchase will be made from the supplier(s) and the supplier(s) shall be blacklisted for 3 years (calendar) from the date of issue of letter. In such case the authority will procure the implants from the L₂ bidder at L₁ price.

 The Tender will be rejected if the Tenderer changes any clause or Appearance of the bid
- 19. The Tender will be rejected if the Tenderer changes any clause or Annexure of the bid document downloaded from the web site.20. The authority reserves the right to cancel/reject all the bids or any part thereof without
- assigning any reason thereof.

 21. In the event of any dispute out of the contract, such dispute should be subject to the

- 22. All copies of the tender document should be self-attested and stamped. If any information or documents furnished by the tenderer are found to be incorrect or misleading at any stage, the tender will not be considered for evaluated and rejected.

 23. It would be the responsibility of the Bidder's representative (only one person per bidder) to be present at the venue of opening of Bids. In case of absence of any bidder then bid document will be opened by the committee members.



TECHNICAL EVALUATION:

- As per the checklist (annexure I) the bidders, meeting all the eligibility criteria as given in technical bid will be scrutinized and evaluated for technical evaluation.
- The bidder qualified after the technical bid shall be informed for opening of price bid.
- The price bid of all the technically qualified bidders will be opened for scrutiny of financial bid.

SELECTION OF BIDDER:

The bidder Quoting lowest price for orthopedic implants & Items to DHH/BBMC&H, Balangir, will be selected as L₁ bidder. The bidder should quote the list of items as mentioned in **annexure -IV**.

In case of tie-up of price bid, the following parameter will be considered:

• Bidder who has supplied implants to more no. of Govt. institutions during last two years will be given priority first.

• Further tie up of Bidder having higher average annual turnover at sl.no-11 of checklist will be considered.

RAISING OF INVOICES:

The bills will be raised in the name of the Superintendent, Bhima Bhoi Medical College & Hospital, Balangir and the agency will submit the bills to the Additional Medical Superintendent (store), BBMC&H, Balangir. After receiving bills, it shall be further verified by discussion with concerned Doctor & Nursing officer or any appropriate person if needed. The verified bill will be then submitted to the office of the Superintendent, Bhima Bhoi Medical College & Hospital, Balangir for processing of payment.

PERIOD OF ENGAGEMENT/DURATION OF CONTRACT

The agency will be engaged initially for a period of **06 Six month**, which may further be extended by the Authority subject to satisfactory performance and requirement of the hospital authority.
